## DECLARATION

Pursuant to the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), I declare as follows:

1. I have provided my personal data and agreed to the processing of my personal data on a voluntary basis;
2. At the same time, I declare that I have been informed that:
  - a. The Controller of my personal data is Alfred Nobel Business College (the ANBC) based in Malta;
